The MUNICIPALITY OF FORTALEZA has received funds from the World Bank toward the cost of the FORTALEZA SUSTAINABLE URBAN DEVELOPMENT PROJECT (FORTALEZA CIDADE SUSTENTÁVEL – FCS), of the Municipal Secretariat For Urban Development And Environment (Secretaria Municipal do Urbanismo e Meio Ambiente – SEUMA), and intends to apply part of the proceeds for consulting services, in compliance with the Procurement Regulations for Borrowers for Investment Project Finance Operations – August 2018.

The consulting services include SUPERVISION AND TECHNICAL ADVISORY OF WORKS FOR THE FORTALEZA SUSTAINABLE URBAN DEVELOPMENT PROJECT (FORTALEZA CIDADE SUSTENTÁVEL – FCS), regarding engineering aspects, risks and social impacts and risks and environmental impacts of the following projects: a) Localized Pollution Reduction in Streams of the maritime shed basin ("City Waters"), which has as main objective demonstrating viable alternatives for improving beach bathing through a set of sanitation and water resources interventions in the western sector of the VM basin, through various activities in the sanitation area; and b) Renewal of Rachel de Queiroz Park ("Natural Systems Network"), which has as main objective allowing integration between the built and natural environment, aiming at improving the quality of life of the inhabitants of Fortaleza, over the revitalization and expansion of green areas in the municipality, through the implantation of the Rachel de Queiroz Park. The services has a duration of 24 (twenty-four) months, from the issuance of the Service Order.

Interested Consultants should provide information (portfolios, list of executed contracts and other similar documents) demonstrating that they have the required qualifications and relevant experience to perform the Services.

The shortlisting criteria are: a) it has executed supervision contracts for basic sanitation infrastructure works, such as: water supply, sanitary sewage, drainage and solid waste, also including social management activities and/or environmental supervision and/or monitoring the implementation of constructions works, compatible with resources and operational complexity and timeframe with the proposed consulting services; b) it has performed consultancy services in supervision of urban works, with international funding.

Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III. Governance, paragraphs 3.14, 3.16 and 3.17 of the World Bank Procurement Regulations for IPF Borrowers dated August 2018 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a Joint Venture and/or a subconsultancy.

A Consultant will be selected in accordance with the **QUALITY-BASED AND COST-BASED SELECTION (SBCQ)** method set out in the Procurement Regulations the World Bank.
